Subject: Intimation under Regulation 30 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 – Disclosure of outcome of litigation

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation to our earlier communications dated 2nd July, 2025 wherein the Company had informed that Division Bench of Hon'ble Delhi High Court vide its order dated 1st July 2025, had dismissed the appeal filed by the Company against the interim order dated 17th July, 2023. to the extent that it enjoined the Company from carrying forth their business in travel luggage under the trademark "CARLTON".

In this regard, we hereby inform you that the Company had filed Special Leave Petition before the Hon'ble Supreme Court of India against the said order of Division Bench of Hon'ble Delhi High Court which came up for hearing on 1st August 2025 and the Hon'ble Supreme Court of India vide its order dated 1st August, 2025, a copy of which has been uploaded on website of the Hon'ble Supreme Court on 4th August, 2025, disposed off the petition; allowed the Company to deal with the inventory of products under the mark Carlton subject to terms set out therein and directed that an undertaking be submitted by the Company to Hon'ble Supreme Court of India as indicated in the said order. The order further contains a direction to the Hon'ble Delhi High Court to try and dispose of Civil Suits between the Company and Carlton Shoes Ltd as expeditiously as possible.
