Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in continuation to our earlier communications dated 20th July, 2023, 21st July, 2023 and 26th July, 2023, wherein the Company had informed that pursuant to appeal filed with the Division Bench of Hon'ble Delhi High Court, it had vide its order dated 25th July, 2023, granted stay on the directions contained in the interim order dated 17th July, 2023, to the extent that it enjoined the Company from carrying forth their business in travel luggage under the trademark "CARLTON".

In this regard we hereby inform you that said Division Bench of Hon'ble Delhi High Court vide its order dated 1st July 2025, the copy of which has been uploaded on website of the Hon'ble Delhi High Court and made available on 1st July 2025, has dismissed the appeal filed by the Company against the interim order dated 17th July, 2023.

The Company is seeking necessary legal advice and shall be taking necessary steps with respect to the aforesaid order.
